Mandandeupur Municipality has **allocated funds** from Mandandeupur Municipality towards the construction of Mandandeupur Municipality Building and intends to apply part of the funds to cover eligible payments under the Contract for **01/Works/NCB/MDM/077/078**. Bidding is open to all eligible as per Section V of bidding document.
2. **Mandandeupur Municipality** invites electronic bids from eligible bidders for the construction of **Mandandeupur Municipality Building** under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.
3. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years : **NRs. 145 Millions.**
 - **Minimum work experience of similar size and nature: 1 number of Government Entity Building and value of minimum NRs. 155 Millions**

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours on 17/09/2020** at the office of **Mandandeupur Municipality, Mahadevsthan Kavrepalanchowk**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRS 60,00,000.00** which shall be valid for 30 days beyond the validity period of the bid.
